EXECUTIVE SUMMARY:

The purpose of this report is to recommend approval of the purchase of Chorus licences to facilitate a Cloud based system.

Access to Chorus is currently provided via Derbyshire Police who 'host' the server. Therefore, to access the system, Nottinghamshire staff have to log on to Derbyshire's network via the citrix gateway and then into Chorus. Derbyshire Police are moving to a Cloud hosted version of Chorus this year and therefore will no longer support Nottinghamshire's Chorus access after November 2021.

The direct access to Chorus via a Cloud hosted system will make the force self-sufficient in relation to this intelligence and evidence gathering software.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The majority of the software that Nottinghamshire Police utilises to format, process and evidentially produce telecoms data, is provided by Chorus. Chorus have two main products that Nottinghamshire Police currently have: 'Analyse' (for analysts and investigators with an enhanced knowledge of telecoms investigation) and 'Investigate' (for investigators who have received some training in telecoms evidence).

To approve the purchase of Chorus Cloud based licences for the two telecoms related intelligence modules: 'Analyse' (for analysts and investigators with an enhanced knowledge of telecoms investigation) and 'Investigate'.

The licences run for a core term of two years. An optional 3rd and 4th year is available. The 4th year fees would reduce by £20k to reflect a multi-year licensing agreement.
