## **EXECUTIVE SUMMARY:**

There is a need for some short term capacity building support for Notts SVS Services Board.

Notts SVS Services delivers the PCC's adult ISVA and sexual violence hub and therapy contract. Following unforeseen circumstances including long term sickness there have been some difficulties within the Board and some short term specialist external support is required to build the new Board's capacity.
