<b>EXECUTIVE SUMMARY:</b>
<p>The above project comprises the construction of a new building on the Sherwood Lodge site, together with alteration, conversion and improvements to existing buildings in order to accommodate a Joint HQ for Nottinghamshire Police and the Nottinghamshire Fire and Rescue Service. The works are split between four work packages, the largest work package being the new build.</p> <p>The fourth work package and final element of the project relates to the conversion of the old building that was previously occupied by the Control Room prior to their move to the new building. A competitive tender process has been undertaken and the price of the most competitive tender exceeds the funding allocation within the existing approved capital budget.</p> <p>The scope of the works has not changed and to facilitate the move of the Nottinghamshire Fire and Rescue Service HQ and the Nottinghamshire Police Learning and Development Functions onto the site the scope of works cannot be reduced further.</p> <p>As a consequence the total capital requirement for the Joint Police and Fire HQ project has increased from £18.5M to £19.25M.</p>
