EXECUTIVE SUMMARY:

The PCC is requested to utilise a proportion of the Asset Recovery Incentivisation Scheme known locally as ARIS to support the following interventions:

- The OPCC Commissioning and partnerships team will collaborate with Metropolitan Thames Valley Housing to host an event called the She Is Summit to launch the VAWG strategy. The event is designed by young women for young women and provides a space in which we can showcase the wider work of the OPCC including safer streets.
- To fund a proportion of the Streetwatch scheme which is about local residents promoting good citizenship and supporting a better neighbourhood by patrolling their own streets. They provide visible reassurance and appropriately engage in local issues that matter most in their own community.

There have been 2 successful She is summits, both in London. Here is a video that captures the most recent of these She Is Summit 2023 - Ending violence against women and girls in Brent (youtube.com). The event is 8th March 4.30-8pm at Albert Hall and our target audience are young women aged 13-19 who are in service with voluntary sector providers (Domestic abuse and sexual violence charities, young carers association. The children's society) as well as those currently access Youth and Leaving care services across the city and county. We are hoping to use this event as a way of bringing young women into conversations around the VAWG strategy across Nottinghamshire in a very 'top line' way, whilst empowering them to be part of the change and inspiring them to believe in their capabilities to do so. We have invited a range of inspirational women from across Nottingham and Nottinghamshire, survivors, women who have overcome significant obstacles to turn their experiences into something positive for the community, women who have been through probation services and are now working as mentors, the CEO of a charity, a professional sportswoman etc and will also be running a series of workshops in relation to health and wellbeing, staying safe as a young woman etc and other community led activities- a dance performance, an art therapist building an artwork that has been created by the group, a spoken word poet etc. We will also be ensuring that women are given the opportunity to talk about their worries, concerns, tell us their ideas, share their stories and ask questions. Many services providers across Nottingham Nottinghamshire have agreed to hold a stand/ stall to showcase their services and provide information.

StreetWatch

FINANCIAL INFORMATION

This is a community led watch scheme which allows people to make a difference where they live It is made up of groups of volunteers from their local communities who carry out street walks but have no police powers. It allows local people to help improve the neighbourhoods they live in by walking their own streets and providing visible reassurance and appropriate engagement in local issues that matter most. The groups are managed by a coordinator, who keeps a volunteer list, provides advice, guidance and support and is usually the contact that speaks with the local policing team. If the group sees suspicious activity, they will report it to the local policing team, but will not get involved. Funding from the ARIS will contribute to the software VisaV added to the Notts Alert system. This will be a force wide licence for use in an many areas.
