Re: Request under the Freedom of Information Act 2000 (FOIA)

Thank you for your request for information, which was received by the Nottinghamshire Office of the Police and Crime Commissioner on 18 November 2019.

INFORMATION REQUESTED

Can you say whether Nottinghamshire now has an equivalence of ISVA to other counties in the East Midlands and can you specify the exact contribution by the councils to the support service?

RESPONSE

Under S 1 (1) (a) of the Freedom of Information Act 2000 (FOIA), I can confirm that the Nottinghamshire Office of the Police and Crime Commissioner does hold the information you have requested.

The answer provided is based on the assumption that the enquiry is about the funding for the Survivor Support Service, which is a distinct element of the ISVA service, and which provides informational, practical, emotional support and advocacy to adult survivors of child sexual abuse which took place in institutional care.

The two attachments set out the funding contributions to the Survivor Support Service from April 2019 to June 2022, and the PCC's best understanding of the numbers of ISVAs in the East Midlands.
