**RESPONSE**

Under S 1 (1) (a) of the Freedom of Information Act 2000 (FOIA), I can confirm that the Nottinghamshire Office of the Police and Crime Commissioner does hold the information you have requested.

The OPCC has assessed the information requested and has determined that Section 40 (2) of the Freedom of Information Act (FOIA) 2000 (Personal data of a third party) applies to some of the information you have requested.

Personal information for instance, would refer to anything which could identify an individual – (in this case, the name of the individual at the company the Commissioner visited). As the individual has not given their consent for their name to be processed by the OPCC wider than the original processing purpose, the OPCC has determined that this information should be exempt from disclosure by virtue of Section 40 (2) FOIA 2000, as disclosing this information to you would contravene the first principle (Lawfulness and Fairness) as set out in the Data Protection Act. The OPCC does not believe that the release of the individuals name would be fair or lawful under the terms of the FOIA, as the data subject will have no expectation that their personal information is
