Thank you for your request for information, which was received by the Nottinghamshire Office of the Police and Crime Commissioner on 25 July 2022.

**INFORMATION REQUESTED**

- Following receipt of her driving ban, can you confirm how the PCC will now travel to attend meetings, events and functions and how the cost of this will be met?

**RESPONSE**

Under S 1 (1) (a) of the Freedom of Information Act 2000 (FOIA), I can confirm that the Nottinghamshire Office of the Police and Crime Commissioner does hold the information you have requested.

Please find below answers to your question:-

- The PCC will travel by public transport to attend meetings, events and functions. The PCC decided when she was elected in 2021 that she would not claim expenses for travel around Nottinghamshire and this has not changed. The Office of the Police and Crime Commissioner is not involved in organising any travel for the Commissioner around the police force area, including from home to work therefore any fees incurred from this will be paid for personally by the PCC. However, any expenses incurred outside of Nottinghamshire for business purposes, where public transport would be
