MoJ COVID-19 Emergency Fund List 2020

In May 2020 the Ministry of Justice (MOJ) provisionally allocated the Nottinghamshire Police and Crime Commissioner (PCC) a proportion of money to increase the response to vulnerable people living in fear and at increased risk of harm as a result of the Covid 19 pandemic. This funding was split into four funding pots as follows:

- Funding for Domestic Abuse services already commissioned by the PCC;
- Funding for Domestic Abuse services not currently commissioned by the PCC;
- Funding for Sexual Violence Service (whether commissioned or not by the PCC); and
- Rape Support Fund extraordinary funding. In Nottinghamshire the PCC applied for this funding because the MoJ's Rape Support Fund is devolved locally to be PCC. Only organisations currently funded by the Rape Support fund were eligible to be included in the funding.

All funding is subject to organisations meeting specific funding criteria.
