### EXECUTIVE SUMMARY:

The Violence Reduction Unit seek approval of spend to fund an Inspector post to lead on the development of a Focussed Deterrence model on behalf of the PCC, VRU and Strategic Violence Reduction Board.

The secondment will be for an initial period of 8 weeks at which point it will be reviewed. The spend, which has been provisionally allocated from the VRU budget is £12,514.


### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

There is an opportunity to submit a bid for funding to the Youth Endowment Fund in March to fund the implementation of a focussed deterrence model in Nottingham and Nottinghamshire. This is an evidence based model which seeks to support children and young people at the highest of risk of exploitation and involvement in serious violence.


The Strategic Violence Reduction Board, Chaired by the Police and Crime Commissioner, approved the exploration of a bid in December 2021.


Due to the limited capacity within the VRU team and the desire to explore a police led model, the secondment of a police Inspector to undertake this work was determined to be the best approach.
