TITLE: Policing Business Services (PBS)

**EXECUTIVE SUMMARY:** An outline business case was put forward in March 2013 by DCC Edens to move from the 'ad hoc' sharing of services to a fully integrated single shared service centre providing operational and strategic business support to regional forces. Transactional services for Northamptonshire and Nottinghamshire are not in scope as they will be delivered through the Multi-Force Shared Service arrangement (MFSS).

On 1<sup>st</sup> May 2013 there was a meeting of the ACPO Resources Programme Board and the outcome was, for business support services, that Nottinghamshire and Northamptonshire would sponsor the development of a business case. An initial Business Case was prepared and approved in June 2014.

This business case is now being reviewed by the new Programme Director for PBS (appointed in March 2015) and an update on the programme will be presented to at the Strategic Resources and Performance meeting in July.

Start up costs for PBS from the initial business case would be approximately £1.6 million. Once the business is up and running, it would operate as any other commercial entity with surplus revenue being returned to the Forces.

The original business case assumed savings of 18% amounting to £3.56 million across both forces. If more radical options were considered it was believed that a best case scenario of up to 30% amounting to £5.473 million could be possible. This business case is being reviewed as part of the detailed design phase and will be updated in July 2015.
