TITLE: Agile Working Business Case / Middleware Contract Award

EXECUTIVE SUMMARY:

Approval is sought to approve the Agile Working Business Case and to sign a contract with HCL for the supply of a Regional Middleware Solution, to support mobile working across the East Midlands Region

Nottinghamshire will be the lead force for the regional solution and this contract.

Each force currently has separate mobile working solutions, many of which are approaching the end of their operational life. The new regional solution will provide additional process improvements, opportunities for further collaboration and economies of scale.

The costs associated with the project in respect of Nottinghamshire are split between capital and revenue. There is budget for this project, a separate Decision Form has been raised in respect of a reallocation between Capital and Revenue.

The Regional Agile Working Project costs in 2015/16 it will be £510k Capital and £548k Revenue (£685k upfront project costs less £138k realisable benefits). In 2016/17 it will be £350k Capital and £340k Revenue. The Agile Working business case costs do not include the budgeted requirement of £493k (Capital) in respect of independent Nottinghamshire mobile working initiatives.

Of this spend, the Middleware costs in 2015/16 it will be £218k Capital and £98k Revenue, in 2016/17 it will be £175k Capital and £196k Revenue.

There are ongoing annual cashable savings of £125k in respect of the end-of-life legacy middleware solution and over £300k in respect of the current Network Provider/Mobile Data contract. There are also significant operation benefits/avoided costs associated with maintaining the ability of Nottinghamshire Officers to be able to access data and systems from the field.
