**TITLE: Capital programme virement request period 8 2015-2016**

#### **EXECUTIVE SUMMARY:**

A request for the following virement within the capital programme 2015-2016

- £0.150m for the telephony project which has been a major on-going project. In 2014-2015 it was estimated that the project could be completed for £0.150m less and this was removed from the programme as a saving. However this has not proved possible and the virement is to complete the project within its original budget. Monies to be vired from SQL Server (£0.120m) which no longer qualifies as a capital project and Energy Initiatives (£0.030m) which are no longer being pursued.
- £0.034m to complete additional statutory custody improvements
  - New cell fire fighting equipment (£0.010m)
  - Extra uninterrupted power supply to Bridewell lighting (£0.002m)
  - Extra CCTV cameras and a DVR at Mansfield (£0.014m)
  - Extra consultant fees (£0.008m)
 Monies to be vired from Energy Initiatives, which are no longer being pursued.
- £0.021m to complete refurbishment works at Broxtowe police station, wrongly offered as a saving during scrutiny review. Monies to be vired from Energy Initiatives, which are no longer being pursued.
- Budget remaining for Energy Initiatives (£0.007m) is identified as an underspend as the post of Environment Officer is currently vacant, therefore no initiatives are currently being pursued.


