TITLE: Additional 2015-6 Community Safety Fund grants

EXECUTIVE SUMMARY:

The PCC has agreed to support the following initiatives for the remainder of 2015-6:

- 1. Communities Inc: £2,000 to deliver additional hate crime reporting work:
- 2. Equation: £6,858.68 to deliver work to support girls affected by gangs;
- 3. Nowchurch: £400 to deliver mentoring with offenders who are substance misusers.

This is a total of £9,258.68 to be funded by anticipated underspends within the community safety grant.

1. Devon & Cornwall Office of the Police and Crime Commissioner: £4,000 to deliver a pilot to reduce street drinking.

This is a total of £4,000 to be funded by the Prevent Budget.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A business case for each of the above projects has been submitted and considered by the Commissioner, as follows:

Communities Inc – the funding is requested to support existing third party reporting centres which have requested follow on support. The project lead will work closely with the hate crime lead in the county to ensure that there is no duplication with other work and to build in sustainability of the third party reporting centres.

Equation – the funding will support training for professional workers who are in contact with girls affected by gangs. The need for specialist training was identified by the independent research commissioned by the PCC in 2013, which was led by the Health Shop and which recommended that specialist training for professionals in the nature of risk facing girls affected by gangs. The project will also deliver a healthy relationships programme for girls involved in gangs, jointly delivered with the Chayah project.

Nowchurch – the funding will pay expenses for volunteers supporting offenders to stop misusing substances. The initiative has demonstrated success with other offenders.

Devon and Cornwall Office of the Police and Crime Commissioner – the Devon and Cornwall PCC is the Chair of the PCC Alcohol Working Group and is leading a national research project, delivered

by Alcohol Concern, to develop a co-ordinated national approach to street drinking, including development and delivery of guidance and training for commissioners and frontline workers.
