TITLE: Extension of Victim Support and Remedi contracts

EXECUTIVE SUMMARY:

In January 2015 the PCC part-awarded a contract to Victim Support to deliver an integrated victim support service to support all victims of crime and anti-social behaviour, identity theft, road traffic collisions and hate incidents. The contract ran for the period 1 April to 31 December 2015.

In February 2015 the PCC awarded a contract to Remedi to deliver victim-initiated restorative justice support. The initial Remedi contract was for 1 April 2015 to 31 March 2016, with the potential for a one year extension.

In 2015 the PCC commissioned an independent review of victim support services. The consultants proposed a new support model, which was consulted on in March 2016. Following this a new service will be commissioned later in 2016. To allow time for procurement, the PCC is requested to agree to:

- 1. Extend Victim Support's contract from 1 April to 31 December 2016. The value is up to £373,651, to be funded by 66% MoJ Victims' Services Grant and 34% Community Safety Grant; and
- 2. Extend Remedi's contract from 1 April to 31 December 2016. The value is up to £112,600, to be funded by MoJ Victims' Services Grant.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The extension for Victim Support's contract has already been published in Notice of Decision ref 2016.001, however, at that time the contract value was yet to be agreed.

Procurement and legal advice on both contract extensions has been sought which has reported that as:

- the contract lengths fall within the original published contracts' lifetimes (2 + 1 + 1 for Victim Support and 1+1 for Remedi);
- · the original specification is unchanged; and
- the purpose of the extension is fundamentally to allow sufficient handover;

the PCC may, under Regulation 72(1)(e) / Regulation 72(8), lawfully extend the contract without a new procurement procedure.
