TITLE: Jubilee House, Arnold - Proposed Co-location with Gedling Borough Council

### **EXECUTIVE SUMMARY:**

The principle of the sale of Arnold Police Station was agreed as part of a broader Business Case involving the sale and replacement of Carlton Police Station. The agreed proposals included taking a lease of space within the County Council building known as Sir John Robinson House (former Home Brewery building) in Arnold as a replacement for Arnold Police Station. The proposal involved sharing space with Gedling Borough Council community protection staff who were based in this building.

Negotiations with Nottinghamshire County Council have been protracted and costs turned out to be higher than originally anticipated. The County Council were to undertake the necessary building alteration works on our behalf and provided an estimated cost of over £300,000. Following a redesign and value engineering process, this was later reduced to approximately £160,000. However, we were unable to bring these costs within the target capital funding of £100,000. The all inclusive rent for the premises was estimated at £20,000 per annum.

Due to the difficulty in making the project work at Sir John Robinson House and especially the inability to bring the project to fruition within budget, Gedling Borough Council have reviewed options for the co-location to take place within their estate. They have now identified suitable space within Jubilee House which is situated close to their main campus in Arnot Hill Park, Arnold. In anticipation of the co-location taking place at Jubilee House, Gedling Borough Council have now terminated their lease of Sir John Robinson House.

Gedling Borough Council have offered a 10 year lease of space within Jubilee House at an annual, all inclusive rent of £16,000, subject to rent reviews at the end of years 3, 6 and 9 in line with CPI. After two years, the Police will have an annual break option upon the service of 6 months' notice.

Gedling Borough Council will undertake the works on behalf of the Police including additional works for the benefit of their staff. The estimated capital costs are £65,000. They have to complete some enabling works at the Civic Centre first in order to enable staff to be moved out of Jubilee House to free up space. They are currently estimating that the premises will be ready for the Police to move in to in the second half of June, 2017.
