TITLE: AWARD OF CONTRACT FOR UNIFORM MANAGED SERVICES

EXECUTIVE SUMMARY:

1. PURPOSE OF THE REPORT

1.1 Recommend approval for the award of contract to Cooneen at Work Limited.

2. SUPPORTING INFORMATION

- 2.1 The original procurement in 2012 was undertaken via a full EU Restricted tender process with 5 suppliers submitting tender responses in January 2013. Cooneen were evaluated as having the most competitive offer and were awarded the Framework Agreement.
- 2.2 Tenders were evaluated against criteria which was communicated to tenderers in the ITT documents, The criteria were a combination of total cost of service (40% of total), Service Delivery (40%) and Account Management (20%).
- 2.3 Tenderers were asked to submit a total cost per annum for each Force against the tender specification that included the cost of storage, all logistics costs and any finance costs. The Contractor was required to purchase existing uniform from the Force and, thereafter, purchase uniform on behalf of the Force using existing contract prices and contractors and recharge this cost to each Force, so the current cost of uniform supply remains unchanged.
- 2.4 In line with Regulation 33 of the PCR 2015, Call-Off Contracts may be let under the Framework for a maximum period of four years in normal circumstances and can extend beyond the Framework date. No new tender process is therefore required to support this new Call-Off contract.
- 2.5 As Cooneen are the incumbent supplier for UMS for Nottinghamshire Police, there will not be a need for a detailed implementation plan.
- 2.6 It is therefore recommended that a new call-off contract is awarded to Cooneen for a period of 12 months from 01.07.2017 with 3 x 12 months extension options.

The table above shows the historical breakdown of spend for 2015/16, the projected outturn for 2016/17 and the forecast for 2017/18. Recruitment has a significant impact on uniform requirements and therefore costs; recruitment is forecast to increase for 2017/18.

Cooneen have confirmed that the current level of service charge at 17.5% (12.5% + 5%) will remain unchanged should Nottinghamshire Police issue a further one year extension of the current call off contract under the EMSCU frame work contract. This service charge will also be applicable should Nottinghamshire issue a new call off contract under the existing EMSCU framework.

There is no specific financial commitment associated with the extension of this framework, The figures stated within the table above are projected and estimated. The purpose of this Decision Notice is to make the public aware of the intent to extend the Cooneen framework to provide Forces across the country with the ability to continue with its use, ensuring commercial flexibility, service continuity, and value for money during the implementation of the new NUMS (National Uniform Managed Service) framework let by the Metropolitan Police.
