TITLE: AWARD OF Wireless Transformation CONTRACT (TRI FORCE)

EXECUTIVE SUMMARY:

1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for the award of contract for the supply of equipment and licenses for a single core platform with sufficient capacity that the three Forces can be consolidated onto creating a single cloud managed Wi-Fi solution for a period of 1 year to Datrix Limited for the total contract value of £174,954.07.

2. SUPPORTING INFORMATION

This is a new tender that is based on the provision of delivery of equipment and Licenses to be completed by 31st March 2017 in order to build a cloud managed Wi-Fi solution for the Tri-Forces to expand the level of coverage and accessibility to user, visitors, and third-party partners. As part of this growth the overarching management of the cloud is brought together into a single management cloud for the whole Wi-Fi estate through a single portal dashboard.

INFORMATION IN SUPPORT OF DECISION: (e.g. report or business case)

The three forces within the Tri-Force collaboration wish to develop a Wi-Fi solution that supports all three forces and enables seamless movement between forces offering a consistent working experience to officers and staff. This work stream will be developed in-line with the Agility and Remote Access Services work streams to ensure a simple secure and user friendly service across all Tri-Force locations.

The vision for this project is to develop Wi-Fi access across all forces to cover the TFC estate. This should be through a single cloud managed platform to streamline and simplify management across all forces. Standardised wireless networks will be agreed on and how they are managed and maintained. This will help with the consistent working experience that users experience when visiting each force.
