TITLE: Additional funding for Sexual Assault Referral Centre (SARC) 2016-7**EXECUTIVE SUMMARY:**

The PCC funds Nottingham Rape Crisis with an annual grant of £74,000 as a contribution towards the running of the Sexual Assault Referral Centre (SARC) (see Decision Notice 2016.027). During 2016-7 the faced increased costs, particularly Crisis Workers costs. As well as providing 24/7 crisis support to survivors, crisis workers ALSO support survivors to participate in forensic examinations and police video interviews.

The proposal is for the PCC to provide an additional £33,392 of funding for Nottinghamshire Rape Crisis to pay for additional SARC costs in 2016-7.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

Nottinghamshire Rape Crisis is funded to deliver SARC through a grant rather than a fixed price contract. The grant pays for actual costs incurred. The OPCC meets quarterly with Nottinghamshire Rape Crisis who reported early in 2016-7 that Crisis Worker costs were rising. The OPCC reviewed the budget for SARC and requested evidence that the additional costs were actually incurred. This was provided.

The SARC is also funded by NHS England, who advised that they had recently doubled their investment into SARC (providing funding of around £200k per annum) and that no further funding was available.
