TITLE: Award of Body Worn Video Contract for 4 years to Reveal Media Ltd

EXECUTIVE SUMMARY:

1. PURPOSE OF THE REPORT

The Purpose of this report is to recommend for approval the award of a Contract for the provision of Body Worn Video for a period of 4 years to Reveal Media Ltd for the total contract value of £161,528.00.

2. BACKGROUND INFORMATION

A compliant procurement process was undertaken as a collaborative 5 Force (Derbyshire, Leicestershire, Lincolnshire, Northamptonshire and Nottinghamshire), Mini Competition through Body Worn Video Procurement Framework, designed to identify a preferred supplier who would be able to cost effectively meet the combination of Business and IT requirements specified and agreed by EMOpSS and Derbyshire for a suitable, head mounted BWV solution using the current Body Worn Video Framework.

Following the recommendations received from the National Police Chiefs Council (NPCC) that all AFO's within the UK should be issued with a head mounted Body Worn Video cameras in order to capture the line of sight of an AFO. An outline business case was written in 2016 and was signed off and funding approved by EMOpSS Senior Management Board which includes Derbyshire representatives.

A Budget of £513,000 was allocated and the Successful award to Reveal Media Ltd of £161,528.00 generated a saving of £351,472.00.

This is a continuation of a successful scheme for Body Worn Cameras, which has now resulted in them being able to be head mounted.

Paddy Tipping, Police and Crime Commissioner for Nottinghamshire, said: "I'm delighted to see this equipment being rolled-out further, it's definitely the way forward for the future. It is good for everyone as it provides protection for both officers and the public."
