### TITLE: AWARD OF TELEPHONY TRANSFORMATION CONTRACT VARIATION

#### EXECUTIVE SUMMARY:

##### 1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for the contract variation to the Telephony Transformation Contract. This variation is to supply a technical re-design to the telephony cluster to enable Nottinghamshire and Northamptonshire to support and maintain their own telephony platforms and eliminate or reduce the support dependency on any force.

The original award for the Tri-Force (Leicestershire / Nottinghamshire / Northamptonshire) incorporated the build of the infrastructure and ongoing support and maintenance for a period of 3 years (with the option of 2 x 1 year extensions) by Datrix Limited for the total contract value of £535,251.56 (TRI100002). This was then further extended to a total contract value of £605,521.66 (TRI100013).

The variation to cover this latest re-design for Nottinghamshire and Northamptonshire is for a further contract value of £26,375.

##### 2. SUPPORTING INFORMATION

A detailed design session took place which identified the current provision for each of the forces (Nottinghamshire and Northamptonshire) and what additional requirements there would be to achieve individual clusters.


