**TITLE:** County LAAA2

#### **EXECUTIVE SUMMARY:**

This decision form sets out proposed expenditure in support of the core aims of Round 2 of the Local Alcohol Action Area Plan (LAAA2) for Nottinghamshire County: preventing alcohol-related crime and disorder; reducing alcohol-related health harms; and generating economic growth by creating vibrant and diverse night time economies.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

#### 1. Provision of vulnerability training (including bar staff and door staff):

Training will be delivered free of charge by the police licensing team. A small amount of funding is requested so that modest refreshments can be provided during all training sessions as an incentive for venue bar staff and door staff to attend.

#### 2. Expansion of 'safe space' provision:

The requirement for safe spaces will vary across the County area depending on the local context. As such, a scalable approach has been adopted which will seek to have a safe space most appropriate to the local context and anticipated demand: from a dedicated safe space (specific premises managed, staffed and equipped as a nominated local safe space), a dedicated 'in venue' safe space (specified room within a licensed premises or late night refreshment venue which is

equipped as a dedicated safe space with staff trained to provide support if required) through to a nominated 'in venue' safe space (a pre-identified room within a licensed premises or late night refreshment venue which is nominated as being suitable to act as a safe space if required, with staff trained to provide support as and when required).

Nowhere in the County area has been assessed as sufficiently busy to warrant a dedicated safe space although several areas (Mansfield, Newark and West Bridgford), may be sufficiently busy to require a dedicated 'in venue' safe space. Where a room within a venue is required initial enquiries suggest venues will be able to be provide this free of charge, but safe space equipment will be required.

It is anticipated that the County area would benefit from some form of safe space in each of the seven (7) locations listed below:

- Mansfield\*
- Hucknall\*
- Worksop\*
- Newark
- West Bridgford
- Beeston
- Arnold

Each safe space will need a safe space kit. Enquiries with the city safe space identified the equipment required and a County Safe Space Kit would include the below items shown with associated costings:

- £33 St John Ambulance large kit £31.30
- £50 Sick bags (good quality medical supplies)
- £10 Wet wipes (medi pack 200)
- £20 Gloves per 100 (x12 small, medium, large).
- £22 Hand gel (50ml x10)
- £10 Ice Packs (10 packs)
- £10 Cling film
- £5 Foil blanket (6 pack)

Safe Space Kits (£160 x 7 venues) = £1,120

To support the roll out of the safe spaces a training package will be offered to a small number of nominated staff from each of the 7 venues in the form an the 'enhanced crew training package', which is offered by Drinkaware at a cost of £1,200 for the session. This will include training on advice on supporting people who may use the safe space.

Safe Space Training = £1,200

Total costs for Safe spaces = £2,320

#### 3. Responsible retail training:

To be provided by Fraser Brown solicitors free of charge, using local venues which will also be provided free of charge. Seven training sessions will be provided in each of the locations that will have safe spaces. A budget of £20 is requested to provide teas and coffees at each session. 7 sessions x £20 = £140 budget for refreshments.

A publicity campaign using Drinkaware 'Mates in a state' posters will support responsible drinking and retailing through visible reinforcement in risky on and off licensed premises identified through

Inn Keeper and liaison with local licensing officers and neighbourhood policing teams. The posters are free to download, but there is a printing cost expected to be £500 for 1000 posters.
