BME Recruitment Strategy – PATRA and Nottinghamshire Police Joint Marketing Strategy

EXECUTIVE SUMMARY:

The Chief Constable recently met with the Chief Executive of PATRA incorporating ACDA to discuss how both organisations can work together to improve the number of BME officers and staff employed by the Force. It is proposed to provide £5,000 to PATRA for developing a joint marketing strategy with the BME community focus initially on police constable degree apprenticeships.
