TITLE: AWARD OF WAN NETWORK CONNECTIVITY SERVICES

EXECUTIVE SUMMARY:

1. PURPOSE OF THE REPORT

The purpose of this report is to recommend approval for the award of contract for WAN Network Connectivity Services. This contract is for the purchase of the required WAN network connectivity to a centralised network data centre and any-to-any connectivity between all sites.

This is a direct award for connectivity services to be awarded to Virgin Media Business for a period of 36 months, with a total contract value of £779,994.85 - capital cost of £54,235 and annual ongoing revenue cost of £241,919.95. This will give us estimated revenue saving of £29,669.10 against current annual revenue.

2. SUPPORTING INFORMATION

This is a new provision to upgrade the network connectivity in support of the WAN equipment roll-out (TRI1000012) for Nottinghamshire Police. As part of an earlier consultation the required hardware has been specified and verified by Nottinghamshire and is currently being rolled out.

This contract is to procure upgraded network connectivity for Nottinghamshire Police in order to deploy the full solution. The solution will see some 40 Nottinghamshire sites connected via a single secure MPLS cloud giving flexibility for growth. This will provide a consistent core provision of hardware/connectivity to meet the requirements of the next 5-10 years.
