TITLE: Additional Commissioned Projects 2018/19

EXECUTIVE SUMMARY:

The PCC has agreed to support the following initiatives for the remainder of 2018-9:

- 1. Muslim Hands £25,000
- 2. Second Chance Learning Academy £10,000

This is a total of £35,000 which shall be met from within the 2018/19 Community Safety Fund.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A business case/application form for each of the above projects has been considered by the Commissioner as follows:

- 1. Up to £25,000 to Muslim Hands for the 'Being Proactive to Engage' project. This funding application was originally provisionally agreed as part of the 2018/19 Community Safety Fund but required further work to develop the project this development work has now been completed. This project will work with Kurdish individuals and individuals from new and emerging communities who are both at risk of reoffending and at risk of offending. A mentoring scheme will be offered for individuals coming out of custody to reduce their reoffending. Community events will also be organised to engage individuals at risk of offending and help increase understanding, participation and socialisation between communities.
- 2. Up to £10,000 to Second Chance Learning Academy to deliver one equipped2succeed 10 day programme. Second Chance Learning originally applied to the 2018/19 Community Safety Fund and were unsuccessful. However following further development of a business case the PCC has agreed to fund. This 10 day equipped2succeed programme will benefit young people looked after in transition to independence and care leavers one of the groups most at risk of being involved in crime or becoming victims of crime. This programme will integrate personal development with physical arts and art activities to equip those looked after and leaving care to thrive, positively move forward, achieve and maintain well-being.
