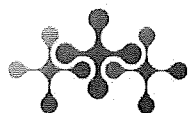

TITLE: Managed Service for Uniform**EXECUTIVE SUMMARY:**

Nottinghamshire Police currently use Cooneen at Work Limited to deliver its outsource managed service for uniform. A further extension to the service is required for a single 12 x months. This is a continuation of the service already being provided to Nottinghamshire Police and is within the contract terms CN1001591


The total amount is £620,622.00 from revenue. The service base cost is £25,000. Negotiation took place to reduce the price however, Cooneen won't award any discounts to us. We have clarified the price increase further and Cooneen came back to say that the 2-3% would have been an increase on the total charge (base and % per unit) however they have agreed to not uplift by 2-3% at all and the price will remain for 12 months.

Email from Heidi Taylor -

The original budget for 18-19 is £595,937.96 (Apr-Mar) but I am going to have to adjust this because of the recruitment plans by a further £13,285 and also by £11,400 to cover the measuring service costs.

These might be over-estimated but it gives you a starting point.

The budget includes the £25k Management Fee and also the 2.5% price increase




