## TITLE: Criminal Justice Substance Misuse Review 2018

## **EXECUTIVE SUMMARY:**

The PCC co-commissions specialist substance misuse support for adults who are in the criminal justice system: the Clean Slate service in the city and the Change Grow Live service in the county. Clean Slate is due to be recommissioned during 2018 whilst the Change Grow Live service has been extended until March 2020. In addition to these services, the PCC has, through the county's community safety partnerships, funded a number of "assertive outreach" services which are delivered by Framework and CGL. These services reach out to individuals with complex needs that often include street homelessness, mental ill health, substance misuse and social care.

Since the Change Grow Live and Clean Slate services were commissioned, the criminal justice landscape has changed. The PCC now wishes to commission an independent review to identify how best to provide specialist criminal justice substance misuse support in Nottingham and Nottinghamshire from April 2019 onwards.

The PCC is requested to approve:

- issuing a request for proposals of up to £25k to deliver an independent review of criminal justice substance misuse support in Nottingham and Nottinghamshire, to be funded by Community Safety Grant;
- inviting a list of specialist consultancies, as well the local universities, to submit a proposal.

## INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The aim of the review is to reduce future substance misuse related harm in Nottingham and Nottinghamshire by identifying the best possible criminal justice substance misuse delivery model from April 2019. Objectives including identifying and evaluating best practice, evaluating the effectiveness of the different models in the city and county with specific reference to criminal justice outcomes, analysing likely future demand and working with service users and stakeholders to develop costed options for future delivery.

The PCC's Standing Orders allow for procurement of goods and services under £25,000 to be managed by acquiring three quotations. For the review, quotations/proposals will be sought from a minimum of 5 organisations. This approach is suggested as the best way to meet standing orders and make the most efficient use of limited OPCC resources in managing the review. In addition, the review must be complete by early October in order to feed into city and county commissioning timetables.
