TITLE: Sale of Worksop Police Station, Potter Street, Worksop

## **EXECUTIVE SUMMARY:**

Following the decision to move from the former Worksop Police Station to the Council Offices at Queens Buildings, Potter Street, Worksop, the site was placed on the open market.

Following a full marketing exercise by the Force's Agents, Lambert Smith Hampton, it is proposed to accept the unconditional offer from Glyn Beech and Julie Taplin which is detailed in the attached Heads of Terms.

Following the move to the Queens Buildings in August, 2018, it became apparent that insufficient car parking for Officers' personal vehicles was available and it would be necessary to either retain 12 spaces within the former Police Station site or to rent 12 spaces in an appropriate location nearby. The cost of renting 12 spaces would be at least £3,888 per year. The purchaser is willing to lease back 12 spaces for 20 years at nil rent and this forms part of the agreed Heads of Terms. The value of this free parking is £77,760 plus future rent inflation. The highest offer received amounted to an additional £45,000 but did not include any free car parking and therefore the recommended offer is considered to represent the best overall value.
