TITLE: Archive Storage Expansion Chunks – ref previous decision record number of 2018.028. / 2018.039.

EXECUTIVE SUMMARY:

For the supply of two additional Archive Storage Expansion Chunks to be provided by CDW for the period 1st October 2018 to a variation end date of 30th September 2023.

This is a variation to the current contract with CDW (CN1001780) where we purchased a suite of Dell Isilon storage requirements.

The original contract was to purchase a replacement/refresh of the existing archive storage we use for our Hi Tech Crime Unit (DIU) and Technical Surveillance Unit (TSU). The solution was also to be used to accommodate the data being brought over on the POLIT move (DN 2018.028).

Further to the original contract, there was a variation to cover storage switches which weren't covered by the original requirement specification (DN 2018.039).

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

DIU is the Force's No 1 data storage consumer resulting from the constant rise in data storage on home PCs and mobile phones downloaded during investigations. When DIU fill up their storage capacity, the unit has to stop work and cannot perform the business function they are here to do.

This variation to contract is required to enable Information Services to rapidly procure more storage when DIU's data consumption reaches a certain threshold (10 – 20% space availability) to ensure there is no disruption to DIU's ability to function.

The total original contract value was £408,274.56 (capital budget).

The first variation to contract value was £33,086.44 (capital budget).

This variation to contract value is £87,999.76 for two additional chunks of storage (capital budget).

The new varied contract total value will be £529,360.76.


