**TITLE: Development of Nottinghamshire Victim CARE Website** 

## **EXECUTIVE SUMMARY:**

The PCC currently commissions the Nottinghamshire Victims' CARE (Cope And Recovery Empowerment) service. The service provides victim-centred and outcomes focussed restorative and other support to empower victims and survivors to cope and recover from crime, anti-social behaviour, hate incidents and identity theft. It empowers resilience, protecting victims from further harm and helping to prevent repeat victimisation.

In addition, the PCC works with his local authority and health partners to co-commission a range of domestic and sexual violence support services.

The Commissioner would now like to commission a Nottinghamshire Victims' CARE website to support and promote the help available for victims and survivors of crime in Nottingham and Nottinghamshire.

The PCC is requested to approve:

• undertaking a new round of procurement for the design, development and on-going hosting, support and maintenance for a Nottinghamshire Victim CARE website. This procurement process will be managed by East Midlands Strategic Commercial Unit (EMSCU) with a total budget of up to £45,000. This would be for the period January 2019 to March 2022.

## INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

Please see previous decision form 2018.065 for further background to this decision.

In September 2018 a Request for Proposals was issued to six specific organisations with previous known experiences providing similar websites – the maximum cost for this piece of work was up to £25,000 for the design, development and subsequent hosting, support and maintenance of the website. Unfortunately no bids were received and feedback in relation to this was that cost was the main barrier.

In October 2018 a Request for Information was sent out to the market, via EMSCU, asking for advice around more realistic costings for this piece of work. 13 responses were received and we have utilised these responses to revise the website specification and costings.

We are therefore proposing to undertake a new procurement process for the development of the Nottinghamshire Victim CARE website. This process will be managed by EMSCU with a total budget of £45,000. The contract will run from the 1<sup>st</sup> April 2019 to 31<sup>st</sup> March 2022.
