### EXECUTIVE SUMMARY:

Funding in 2019/20 to support the Nottinghamshire Best Bar None scheme.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The Nottinghamshire Best Bar None Scheme launched in 2015. This is a nationally accredited scheme aimed at improving the operating standards of licensed premises within the county, reducing drug use and alcohol / drug related incidents in venues.

The scheme has helped to build positive relationships between the police, council licensing officers and licensed premises, encouraging a partnership approach and enabling venues to seek support at the earliest opportunity, rather than allowing issues to escalate.

The scheme works in partnership with all county boroughs and districts and enables local authorities to promote best practice, ensuring a safe and enjoyable night out for customers.

The project will be managed by a competitively procured, external contractor. Day to day reporting is to a project board, consisting of the licensing managers from Broxtowe, Mansfield and Rushcliffe. This is overseen by the Executive Board on a quarterly basis (with senior local authority, Police and OPCC representatives).


Funding will pay for the co-ordination / management of the county wide scheme, as well as the Best Bar None app and website hosting, facilitation of a public vote, for marketing and certificates, and towards the awards ceremony.


