#### **EXECUTIVE SUMMARY:**

Funding towards the Community Solutions Conference to be held on 21.06.19 at the Nottingham Ice Arena.

#### **INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

Powell and Barns Media Ltd have been asked by the OPCC to convene an interactive conference around working together to tackle youth violence, knife crime and gang culture. Aimed at parents and carers, the conference will bring together statutory agencies, parents, community leaders and experts to:

- provide an opportunity to explore the successes and progress made in tackling knife crime and build on best practice;
- explore how relationships between statutory agencies, parents, carers and the wider community can be strengthened and improved; and
- provide parents, carers and the wider community with information about local and national services and support.

The event will be live streamed on social media to allow engagement and inclusion for people who cannot physically attend.

Powell and Barns Media will film, edit and show at the conference 'vox pops' with parents and carers of young people involved in or on the periphery of knife crime.
