**TITLE: Life Skills Education**

#### **EXECUTIVE SUMMARY:**

Three years funding is being sought by the Life Skills Education Charity to create a new DARE primary programme dealing with drugs and alcohol and adding knife crime and hate crime to the risky behaviours covered.

The aim of the new programme is to provide a consistent, quality education programme to all year 6 primary school pupils in Nottingham and Nottinghamshire addressing risky behaviours associated with hate crime, knife crime, drugs and alcohol.

Three years funding is therefore being requested as follows:

2019/20 - £108,000

2020/21 - £100,000

2012-22 - £100,000

#### **INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

An application form has been submitted to the Chief Constable and PCC detailing the initiative as well as a detailed project plan and budget breakdown.

This new DARE programme will be offered at 50% of the cost to all state funded primary schools in the County of Nottinghamshire and the City of Nottingham of which there are 353 with approximately 13,350 pupils in the target age group. The project will run for three years.

The project will involve the creation of a new programme including new literature, videos new characters and new work books with cartoon story lines and interactive activities. Existing DARE officers will be engaged in the development and receive a day of additional training to familiarise themselves with the revised subject material. Each school will be contacted personally to offer the programme.

This new programme will build resilience to crime in the young people who graduate from it, helping them to find the right support should they ever fall victim to crime. It will also help to impact on the local communities through a reduction in crime and ASB.


