TITLE: Re co-commissioning of criminal justice substance misuse support services in the city 2019-2023 including award of contract

EXECUTIVE SUMMARY:

The PCC awards a grant every year to Nottingham's Crime and Drugs Partnership. Part of the grant is a contribution to the city's Clean Slate criminal justice substance misuse support service, delivered by Framework. In 2018-9 the PCC's contribution to the Clean Slate service was £296,513.

The Clean Slate contract expires in September 2019. The City Council, as the lead commissioner, recommended that a new service be commissioned and published a tender for a replacement service in January 2019.

The PCC is asked to confirm his verbal agreement to re co-commission the city's criminal justice substance misuse support service. This approach is in line with the recommendations of the PCC's 2018 independent review of substance misuse support services.

Award of contract

Following the PCC's verbal agreement to co-commission a replacement service, the City Council published a tender for the delivery of a criminal justice substance misuse support service in January 2019. A panel was convened by Nottingham City Council on 23 March and agreed to award the contract to Framework for the period September 2019-21, with two possible one year extensions.

The published value of the contract was £5,854,000, including any possible contract extensions, of which the PCC's contribution is £293,876 pa (£1,175,504 over the lifetime of the contract including any possible contract extensions).

Approval

The PCC is asked to confirm his verbal approval for the following:

- 1. To continue to co-commission city criminal justice substance misuse support services, with the City Council acting as the lead commissioner;
- 2. To contribute £293,876pa towards to the service, to be managed through the annual CDP grant agreement and funded by Community Safety Grant;
- 3. To agree the award of the contract to Framework as recommended by the City's Council's procurement team.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

In 2018 the PCC commissioned an independent review of criminal justice substance misuse support services. The review found that criminal justice substance misuse support services generally help to reduce re-offending the quality of provision, that provision in the city is good and that the service should be recommissioned.

The report also recommended that the CDP in Nottingham City continue to lead on cocommissioning the service in consultation with the PCC and justice stakeholders. Further recommendations were made about new inclusions into the service specification. These related to areas such as support for female service users and developing a voluntary attendance pathway with Nottinghamshire Police. They have been included in the specification for the new service.
