**EXECUTIVE SUMMARY:** CN1001840 expires 31.10.19 however the new Met framework is not available to forces until 01.02.20. We would like to extend the current contract to 29.02.20 (to allow for any delays). This will ensure that the current service provision remains unaffected.

The terms and conditions of the existing contract will remain however there will be a slight increase in charges as the supplier has not increased its prices in the last 5 years. The team that manages emergency boarding up in Nottinghamshire have confirmed that the uplift will be minimal as they only have approx. 10 boarding up call outs per month and approx. 8 /9 of these are paid for by the public.

Contact Management have confirmed they anticipate the increase in charges will be approx. £10 per month (for this extension period) and this equates to approx. £120 per year as whilst the emergency boarding ups are paid for by the public, occasionally Contact Management do have to pick up the charges.

The original contract value is £10,200.00 and the Business Accountant in Finance has confirmed that this is underspent against the contract value of £10,200.00. Therefore this slight increase is within budget and Contact Management are aware of the requirement to remain within budget.
