TITLE: Strategic Review of Youth Diversion Services in Nottinghamshire 2019

### **EXECUTIVE SUMMARY:**

Nottinghamshire PCC would like to commission a suitably experienced research consultant to undertake a review of Youth Diversion Services provided across Nottingham and Nottinghamshire to inform future PCC commissioning intentions. The PCC is keen to develop a local understanding of need and demand for both universal and targeted youth diversion services and consolidate the evidence base on what works in the provision of these services.

The research will comprise of a statistical analysis of available spend and outcome data, qualitative interviews / engagement with key service leads and practitioners and a rapid evidence assessment of what works in providing local targeted and universal youth diversionary services and a secondary data analysis to improve understanding of anticipated demand and unmet need.

The project will map OPCC investment in services related to youth diversion across Nottingham and Nottinghamshire over the period April 2016 to March 2019 – including details of outcomes delivered during the 3 year period and areas of unmet need – and provide an overview of the broader statutory offer of universal and targeted youth diversionary services across Nottingham and Nottinghamshire, highlighting any notable areas of unmet need identified.

The research should aim to consolidate the evidence base on 'what works' in providing youth diversionary services in the local context and highlight any areas of good/best practice identified in the delivery and monitoring of youth diversionary outcomes.

Recommendations will be used to inform future OPCC commissioning arrangements for youth uiversionary services from October 2019. The project should also seek to inform wider partnership discussion on the provision and configuration of local youth diversionary services.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The review has been prompted by a wide range of factors that are likely to have impacted upon service demand and provision over recent years, which include: reductions in public spending on children's services, particularly early and preventative interventions; rises in serious weaponenabled violence involving young people alongside an emerging culture of knife possession among a minority of vulnerable individuals; improvements in partner agency recognition of vulnerability and unmet need, particularly in view of our growing understandings of child sexual exploitation, 'county lines' offending and gang coercion; a recognised lack of strategic governance, leadership and coordination at a local and national level, particularly in relation to local authority duties to 'as far as reasonably practicable, secure sufficient activities for the improvement of the wellbeing of qualifying young persons in the area.

The review supports and compliments the statutory duties of the Police and Crime Commissioner to co-operate with statutory agencies in formulating and implementing strategies to prevent crime

and disorder, achieve value for money in doing so and ensure the welfare of children is safeguarded and promoted. In reviewing the PCC's contribution to youth diversion in the context of other statutory provision available, the project will consider how outcomes in this area can be maximised for the benefit of all stakeholders.
