TITLE: Additional Commissioned Projects 2019/20

EXECUTIVE SUMMARY:

The PCC is asked to confirm his earlier verbal agreement to award funding to support the following initiatives:

1. Stephen Lawrence Bursary – Up to £1,700
2. Taken Too Soon event - £2,837

This is a total of up to £4,537 which shall be met from within the 2019/20 Commissioning budget.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A proposal/application form for each of the above initiatives has been considered by the Commissioner as follows:

1. Up to £1,700 as a contribution to the Stephen Lawrence Bursary. The Stephen Lawrence Bursary is a national bursary that will support Black, Asian and Mixed Ethnicity (BAME) police officers and staff to participate in short term study programmes in the United States. The Bursary will enable selected BAME officers and staff to develop themselves professional and contribute more effectively to their communities. The Bursary programme will run for four years with each PCC being given the opportunity to contribute to the total cost. The Nottinghamshire Police and Crime Commissioner has agreed to contribute a one off payment of up to £1,700 to support this Bursary over the four years.
2. £2,837 to Holistacare Health Limited to pay for stage and sound equipment for the Taken Too Soon event on Sunday 14th July, with the funding paid directly to the supplier. Taken Too Soon was a community event centred around a Nottinghamshire Police v ex pro-celebrity football match which aimed to raise awareness of providers working to reduce serious and violent crime in Nottinghamshire and to raise funds for the Ending Youth Violence Network. Any surplus from the event will be managed by Groundwork Nottingham on behalf of the Ending Youth Violence Network.
