TITLE: Additional support for adult survivors of non recent child sexual abuse affected by the publication of the Independent Inquiry in Child Sexual Abuse's Nottinghamshire report

#### **EXECUTIVE SUMMARY:**

The Independent Inquiry into Child Sexual Abuse (IICSA) held a formal investigation in October 2018 into the abuse experienced by children in the care of Nottinghamshire Councils. IICSA's Nottinghamshire report was published in July 2019.

Support services for adult survivors of non recent child sexual abuse have been in place for some time. However, survivors reported to the PCC and to local authorities that the publication of the report would be very distressing and additional support would likely be required.

On behalf of the IICSA Chief Officers' Group, the OPCC consulted with survivors who requested out of hours telephone support and further help from the Survivor Support Service. Following further discussion, Nottingham City Council and Nottinghamshire County Council agreed to provide up to £25k between them to put in place the following support:

- Out of hours telephone support from 8pm to midnight for the two weeks following the publication of the report
- Additional staff time in the Survivor Support Service to help new survivors accessing the service.

The PCC is requested to agree to vary Notts SVS Services' contract for the ISVA/Survivor Support service by up to £25,000 for 2019-0, to fund out of hours telephone support for two weeks and additional staff time in the Survivor Support Service. The arrangement will operate on an open book basis and will be funded by up to £25,000, to be shared by Nottingham City Council and Nottinghamshire County Council.

## **INFORMATION IN SUPPORT OF DECISION:** (e.g report or business case)

Survivors requested this support. Other options were considered for the delivery of out of hours support. However, CSA survivors specifically requested that the temporary support be delivered by Notts SVS Services. In addition, Notts SVS Services staff already have the skills and experience to support CSA survivors, organisational experience of delivering an out of hours crisis service and can offer a seamless pathway into the Survivor Support Service.
