**TITLE: Award of contract to deliver criminal justice substance misuse support services in the county 2020 - 2028**

#### **EXECUTIVE SUMMARY:**

As outlined in Notice of Decision ref 2019.030, the PCC agreed to co-commission an integrated substance misuse support service with Nottinghamshire County Council.

The County Council as the lead commissioner published a tender in December 2018, following a competitive dialogue process. The dialogue involved 5 bidders and was concluded in September 2018. As recommended to the County Council's Adult Social Care and Public Health Committee on 8 October, the winning bidder was Change Grow Live (CGL).

The PCC is asked to approve the following:

1. The award of the county substance misuse support contract, which includes specific support for criminal justice, to CGL
2. To contribute £318,919 towards the service (£303,732 for the service and £15,187 as an administration fee to the County Council), to be managed through a refreshed Inter Authority Agreement between the PCC and County Council and paid for by Community Safety Grant.

#### **INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

The PCC's 2018 Independent Review in Criminal Justice Substance Misuse Support Services in Nottinghamshire recommended that Nottinghamshire County Council continue to lead on co-commissioning the service in the county, in consultation with the PCC and justice stakeholders. The County Council has led a robust procurement process which identified a winning bidder.

Further recommendations were made about new inclusions into the service specification. These related to areas such as presence in custody, support for female service users and developing a voluntary attendance pathway with Nottinghamshire Police. They have been included in the specification for the new service.
