#### **EXECUTIVE SUMMARY:**

A decision to provide £16,800 to fund Problem Solving training for Police Officers, Police Staff and Partners in support of a recommendation arising out of the Neighbourhood Policing review to reinvigorate effective partnership working and support activity to reduce high severity crime in high harm localities was approved on 24th October 2019 (see decision 2019.056). Since then a further expenditure of £3.125 has been identified to pay for the trainer's travel and subsistence costs.
