TITLE: Sale of Hucknall Police Station, Watnall Road, Hucknall

EXECUTIVE SUMMARY:

Hucknall Police Station was previously the local policing base for Hucknall and the main Force Training Centre. The Police Station moved in February, 2020 to a new Tri-Service Station joint with EMAS and Nottinghamshire Fire and Rescue Service at the existing Ambulance Station site. In October, 2020, training transferred to West Bridgford Police Station pending the permanent move to the new training facility being constructed at the Sherwood Lodge site. The site is now vacant and surplus to requirements and a full marketing exercise has been undertaken by Agents Lambert Smith Hampton.

A total of 5 offers were received. All offers were conditional upon the receipt of planning permission for some form of residential redevelopment.

The highest offer was from Preferred Homes Ltd and is conditional upon the grant of planning permission for the redevelopment of the site for extra care apartments.

The terms of the sale are detailed in the attached confidential Heads of Terms document and include a non refundable deposit to be paid upon exchange of contracts, which will be deducted from the agreed purchase price upon completion, which will take place following the grant of planning permission.
