**TITLE: Nottingham Custody Suite**

**EXECUTIVE SUMMARY:**  
The Capital Programme which was presented at the Police and Crime Panel meeting on 6<sup>th</sup> February 2020 approved a budget for the Nottingham Custody Suite to the value of £12.4m in 2020/21 and future year's budgets of £3.253m.

The custody project is a multiyear project to deliver a new Nottingham Custody Suite at a new location within the City, work is now ahead of schedule, and we are therefore at this point in time predicting that the budget allocated to this financial year is at risk of overspending. It is requested that £600k of budget allocated to 2021/22 is brought forward to 2020/21 to cover the costs.


It is expected that the project will be delivered on budget in totality, but the phasing maybe a little out of line with costs being incurred. For a multi-million pound project, over multi years this is not unusual.
