TITLE: Sale and temporary leaseback of Bridewell Custody Suite, Carrington Street, Nottingham.

EXECUTIVE SUMMARY:

Following the decision to construct a new Custody Suite at Radford Road, Nottingham, the existing Bridewell Custody Suite is surplus to requirements and it is anticipated that it will be vacated in late Summer, 2021.

The freehold interest in the Bridewell was formally vested in the former Police Authority by a Transfer Deed dated 31 October, 2007. The Transfer Deed contains provisions for a future sale of the Bridewell which includes a requirement to undertake a range of building works to separate the building physically and from a services point of view, from the adjacent Magistrates Courts. The Transfer Deed also requires notice of an intention to sell the building to be given to Her Majesty's Courts and Tribunals Service (HMCTS) prior to any sale to a third party. HMCTS have first refusal to acquire the building and there is a provision for the price to be set by arbitration should the parties not be able to agree a price.

On 6th July, 2020, formal Notice was given to HMCTS of the intention to sell the building. On 22nd December, 2020, HMCTS formally responded confirming their intention to acquire the building and making a formal offer.

Negotiations have ensued and the attached confidential Heads of Terms have been agreed for the sale of the Bridewell to the Secretary of State for Housing, Communities and Local Government on behalf of HMCTS. HMCTS are prepared to complete an early purchase (target 1 April, 2021) and lease the building back to the Police until the building is vacated (subject to a maximum of 12 months). The Police will retain responsibility for the running costs of the site until the lease back arrangement is formally terminated on one month's notice following vacation and clearance of the site. No rent will be payable.

There are significant benefits of a sale to HMCTS, especially the removal of the requirement to physically separate the building and services from the adjacent Magistrates Courts and the early sale which will lead to an early capital receipt and the early termination of the obligation to fund the running costs of the building. This will minimise the period of having running costs to pay for both the old and new custody sites, which under normal arrangements of marketing the building, may have led to offers that were subject to planning permission and other matters, which could have led to significant delays in the sale and consequent extended period of holding costs.
