### EXECUTIVE SUMMARY:

The PCC is asked to confirm his verbal agreement to award funding for the following:

J9 Campaign Initiative (Rushcliffe) – up to £364.45 for promotional materials associated with the J9 campaign Initiative in Rushcliffe.

This funding would be met from within the 2020/21 Commissioning budget.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The J9 campaign initiative (Rushcliffe) is a domestic abuse campaign aimed at supporting survivors. Training is provided by DWP - in conjunction with the Rushcliffe MPs office - to businesses and organisations to enable them to become a safe space for victims and help to signpost individuals to the most appropriate support.

The purpose of the PCC funding is to help to provide promotional material that would be distributed to businesses and organisations that have agreed to be a J9 Safe Space for victims of domestic abuse. The aim being that this will help these organisations have to confidence to refer victims to the appropriate commissioned services. This is alongside Nottinghamshire bespoke domestic abuse resources provided by Equation.
