**TITLE: Funding for the National Ugly Mugs Scheme 2021/22**

**EXECUTIVE SUMMARY:**

The PCC is asked to confirm his verbal agreement to award funding of up to £4,000 to support the National Ugly Mugs Scheme and specifically the work they undertake in Nottinghamshire.

**INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

The National Ugly Mugs Scheme has requested financial support from PCCs to enable them to continue operating.

The National Ugly Mugs Scheme is a pioneering, national organisation which provides greater access to justice and protection for sex workers who are often targeted by dangerous individuals but are frequently reluctant to report these incidents to the police. Their work involves processing reports of violence against sex workers; disseminating information to prevent further harms; sharing intel with SCAS and police intelligence; providing support to victims and facilitating their access to police and public services.

In 2020/21 the PCC provided Ugly Mugs with a £4,000 contribution towards their work (see decision notice 2020/040) and the feedback from partners was that they would be keen for this partnership to continue. This new contribution of £4,000 would be from Nottinghamshire for 2021/22 towards the National Scheme and we will seek to get monitoring information from the scheme local to Nottinghamshire and again evaluate over the year the benefit of this contribution.


