EXECUTIVE SUMMARY:
In preparation for a bid submission to the Home Office Safer Streets (Round 4) fund to improve safety and feelings of safety for women and girls, a survey has been developed and plans made for undertaking an online survey to help inform the bid submission in relation to the City Centre.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>The PCC intends to submit a bid of £300k to target the city centre of Nottingham. It is necessary to obtain the views of women and girls who live, visit or work in this target area to provide evidence as part of the bid submission to make the night time economy safer. This cost should be seen as an invest to save. The findings from the survey will help strengthen the quality of the bid. Surveys have been used to good effect with previous bid submissions.</p> <p>It's uncertain as to how many surveys will be completed during the time available but it's estimated that between 200 and 400 surveys can be completed online.</p> <p>There will be two separate costs in relation to this survey as follows:</p> <ul style="list-style-type: none"> • SMSR who are already contracted to undertake survey work for the PCC will be commissioned to undertake the development of the survey, the online set up and design and the data processing, analysis and reporting on or as soon as possible after 10th August 2021 and will report on the findings on 24th August in time for the bid submission on 1st September 2021. • Shake Social will be commissioned to roll out the survey via the Consent Coalition social media accounts and will design the posts, manage the boosted posts and provide analysis of reach.
