EXECUTIVE SUMMARY:

The Police and Crime Panel met on the 8th February 2022 to consider the proposed precept for 2022-23. To support them in this they were provided with budget reports and financial strategies that provided detail on how the precept and government grant would be utilised in 2022-23.

The precept increase proposed of £9.99 for a band D property was agreed by the panel, the Commissioner is recommended to approve this increase.
