EXECUTIVE SUMMARY:

Further to Decision Record 2021.111 which outlined the requirement for Strategic Consultancy and support for the PCC to be provided by Kathryn Holloway this is to request approval to further extend the Strategic Consultancy and Support offer as follows:

- The provision of an additional up to [REDACTED] to Kathryn Holloway;
- The provision of up to [REDACTED] via a new contract with Glen Thompsett

This is a financial commitment of up to [REDACTED] which will come from the Commissioner's OPCC budget and will be spent before 30th June 2022.


INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

In November 2021 a contract was put in place with Kathryn Holloway to deliver Strategic Consultancy and Support to the PCC – see decision record 2021.111 for further detail.


Further consultancy and support is required as follows:

- The provision of an additional up to [REDACTED] to Kathryn Holloway. This is to provide additional consultancy and support and will cover costs of preparation work, hire of any necessary equipment as well as actual consultancy costs. This variation to the existing contract will be undertaken as a single tender award for interoperability reasons and given the immediate need. Legal advice has been sought in relation to this.
- The provision of up to [REDACTED] via a new contract with Glen Thompsett for additional strategic consultancy and support. Under PCC Standing Orders a contract can be made directly via one quote should the value be under [REDACTED]
