EXECUTIVE SUMMARY:

Further to Decision Record 2021.121 and 2022.007, this decision form outlines the Divert Plus budget forecast from April 1st 2022 – March 31st 2024. This is an extension to the Home Office Serious Youth Intervention funding from 2021/22.

Approval is sought for the spend in line with conditions described in the Youth Endowment Fund Grant Agreement. An overall breakdown of the proposed spend is as follows:

In relation to the Staff Costs: in 2022/23 this will include the following:

- Up to £101,500 to the City Council for the provision of Sessional Youth Workers (including travel) for the Divert Plus Project; and
- Up to £19,932 to The Children’s Society to continue to provide Sessional Youth Workers in the County area for the Divert Plus Project between 1st April 2022 and 30th June 2022.
- The remaining balance for County Council provision post 30th June 2022.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

£1,055,760 has been provisionally allocated to the PCC by the Youth Endowment Fund to continue the delivery of the Divert Plus Programme. This funding has been awarded in two phases:

1. Pilot phase April 2022 to October 2022 £263,940; and
2. Efficacy phase October 2022 to March 2024 £791,820

Allocation by financial year:

- 1st April 2022 to 31st March 2023 £527,880
- 1st April 2023 to 31st March 2024 £527,880

A breakdown of the proposed spend is detailed above. This decision record seeks approval for the initial procurement decisions as follows:

- A grant of £101,500 will be made to Nottingham City Council for the provision of sessional youth workers during 2022/23. The City Council already have commissioning arrangements in place with a number of providers and will utilise these to provide 6FTE sessions youth workers for the Divert Plus Project.
- An extension to the existing contract with The Children's Society will be undertaken from April 2022 to June 2022 at a cost of £19,932 for the provision of sessional workers in the County for the Divert Plus Programme. As detailed in Decision Record 2020.007 a single tender award was done initially due to timescales. During this period a recruitment drive has been undertaken to recruit sessional youth workers however this has been successful. Therefore whilst alternative arrangements for sessional youth workers in the County are made a further single tender award will be sought to extend The Children's society contract by 3 months.


Minor adjustments to the budget will be managed with the Youth Endowment Fund Programme Manager and monitored by the Divert Plus Project Board.

Any significant budget re-profiles and additional procurement activities will be recorded in subsequent decision notices.
