The Violence Reduction Unit seek approval of spend of £2,188 to contribute to rent for Jawaid Khaliq Boxing Academy.

<p>The Jawaid Khaliq Boxing Academy has been operating successfully for the last 15 years in Nottingham, supporting children and young people in St Ann's to divert them away from serious violence.</p> <p>The organisation approached the Commissioner as their monthly rent of £368.00 for their facility will be increasing to £1,462 per month in August which is prohibitive to the continued running of their intervention.</p> <p>This is a short-term solution to provide adequate time for the organisation to find another source of funding or an alternative facility and will therefore be a one-off grant.</p>
