EXECUTIVE SUMMARY:
<p>Further to Decision Record 2022.044 the total funding award to the Nottingham Crime and Drugs Partnership (CDP) has increased from £240,393.90 to £300,256.90. The additional £59,863 has been allocated to Serious Violence /Youth Prevention Work and extended to cover the full financial year (April 2022 to March 2023).</p> <p>The PCC is therefore requested to confirm her approval to increase the funding to the CDP by £59,863 for Serious Violence / Youth Crime prevention work to cover the whole 2022/23 financial year. The PCC is also requested to approve the proposed dissemination of this Serious Violence funding as detailed below.</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)												
<p>The CDP has been allocated a total of £140,000 of funding by the PCC for 2022/23 to fund Serious Violence / Youth Prevention Work. The CDP, VRU and OPCC have worked together to agree how this £140,000 would be disseminated with final agreement as follows:</p>

Take One	Keeping it Real Mentor Project	20,000	Working with 20 young people aged 16-24. This project has two aims, divert and target. The diversionary activities will focus on early intervention working with those who have been identified as being vulnerable and who may be easily coerced into taking part in risky behaviour. The targeted activities will focus on those who have already been identified as taking part in such behaviours.
Nottingham Forest Community Trust / BBBBs	Targeted Youth Outreach	40,000	Contribution of £40,000 to targeted youth outreach undertaken by NFCT / BBBB's in Nottingham City Centre.
Youth Justice Services	Care Works – Case Management System	30,000	Contribution toward the upgrade of the Care Works case management system to ensure it meets National Youth Justice Board requirements.

As in previous years it has been agreed that this funding would be administered by the Violence Reduction Unit (VRU) with grant agreements being put in place direct between the PCC and the above recipients. This will enable improved monitoring of projects alongside VRU commissioned interventions given the common themes and outcomes.

FINANCIAL INFORMATION

An additional £59,863 revenue funding, from the 2022/23 Community Safety Grant be awarded to the CDP for Serious Violence / Youth Crime prevention work.
